CITY OF KANDIYOHI SPECIAL ASSESSMENT PUBLIC HEARING JULY 16, 2025 7:00 p.m.

The Kandiyohi City Council held a Public Hearing on Wednesday, July 16, 2025, at the City Hall/Civic Center located at 432 Atlantic Avenue Kandiyohi, MN 56251. Present were Mayor Jon Lindstrand; Council Members Toby Giese, Spencer Hunt, and Jeff Clark; City Maintenance, Brandon Huls; and City Clerk/Treasurer, Julie Woltjer. The Public Hearing was called to order at 7:00 p.m.

PUBLIC HEARING

This Public Hearing was called to consider the making of Phase I Street and; Utility Improvement Project, the improvement of McDermott Avenue between 4th Street and 7th Street, Pacific Avenue, Mclaughlin Avenue from 2nd Street to mid-block of 3rd and 4th Street, 7th Street south of US HWY 12, 6th Street south of US HWY12, 5th Street south of US HWY 12, 4th Street south of US HWY 12, and 3rd Street between Mclaughlin Avenue and Atlantic pursuant to Minn. Stat. §§ 429.011 to 429.111. The area proposed to be assessed for such improvement is abutting properties. The estimated cost of the improvement is \$6,250,000. A reasonable estimate of the impact of the assessment will be available at the hearing.

Assessment Process

- City is proposing to assess 20% of remaining costs after grants are applied.
- Estimated total cost of street project = \$6.218 million
- Estimated assessable portion = \$500,000
- Assessments are broken into street portion, water portion, and sanitary sewer portion.
- Standard Lots Abutting footage.
- Corner Lots Assessed at ½ long and ½ short side if project is abutting both sides.
- Water service is installed Flat rate
- Sanitary sewer service is installed Flat rate
- Estimated cost per foot for street portion = \$45/LF
- Estimated water service cost =\$2,200 per lot
- Estimated sanitary sewer service cost = \$2,200 per lot
- Option to prepay assessment to avoid interest

Public Comment – Special Assessment Hearing (Phase 1):

During the hearing, members of the public raised questions and concerns related to Phases 2 and 3 of the infrastructure project. It was clarified that this special assessment hearing was convened specifically to address the estimated costs for Phase 1 only, and that Phases 2 and 3 will be discussed at a later date.

Additional topics of discussion included the size of the proposed new water tower, the potential impact on boulevard trees, and drainage considerations for Center Park.

Maps with our current infrastructure and the Proposed Improvements are posted at the Civic Center/City Office to review.

Council Member Hunt motioned to adjourn at 7:56 p.m., Council Member Giese seconded the motion. No objections were made, and public hearing adjourned.
